- These are the terms and conditions which are outlined in the full Electronic Device User Agreement.
- The full agreement includes spaces for Students and their Parents / Caregivers to enter their names and signatures.
- It is an electronic document which can only be filled out when visiting our school when you sign up for a computer.

The Laptops for Learning User Agreement in conjunction with the Acceptable Electronic Device Use Policies are designed to ensure that devices are used responsibly and ethically for education purposes at Playford International College

This policy applies whenever students are using Student access to, and use of, the Playford International College information technology equipment or services.

ICT System must be:

- Only for school use and with regard to subject work.
- In accordance with the information contained in this user agreement

This policy and agreement, along with any additions and amendments, will remain in force as long as a student is enrolled at Playford International College. If it becomes necessary to add to, or amend the policy, parents and students will be advised.

Failure to meet any of these conditions may result in the removal of access rights to use any eDevices or school provided electronic services (such as WiFi, Internet, desktop devices) while at school for a length of time to be determined by the school.

TEMPORARY LOAN DEVICES

- If the student's primary device is required to be temporarily obtained by ICT, (for example to be repaired) the student will be issued with a temporary loan device. All rules in this agreement will apply to any and all loan devices.
- Invoices may be issued for any damage done to devices should the cause of damage be determined to have voided the manufacturer warranty or the warranty is no longer in effect. This includes malicious or physical damage to the device.
- This agreement outlines that in the case of the loss / damage / theft of the original device, an invoice will be issued for the balance of replacing that device.

WE AGREE TO THE TERMS OUTLINED IN THIS DOCUMENT

Parent / Caregiver Agreement

- I have read and understood the Playford International College (PIC) Laptops for Learning User Agreement and the Acceptable Electronic Device Use Policies document, and understand that student access is granted for educational purposes according to the conditions stated in this policy.
- I understand that the internet is a global network and that PIC will monitor student use of the internet, but PIC is not able to completely control the content or restrict student access to all controversial materials. I agree that I will not hold the school responsible for any material encountered on the internet.
- I am aware that the devices provided to students remain the property of the school and will be subject to a thorough inspection by school staff at any time, until the total agreed price has been paid.
- I am aware that any costs associated with the repair or replacement of information technology equipment (loan equipment or payment arrangement) that has been deliberately or recklessly damaged by my child may be borne by me, the parent / caregiver. I am aware that my signing and returning of this form constitutes a commitment to pay such costs, and that policies relating to the recovery of debts will apply.

- I give permission for my child to be granted access to Playford International College ICT Network, internet and equipment.

Student Agreement

- I have read and understood the Playford International College (PIC) Laptops for Learning User Agreement and the Acceptable Electronic Device Use Policies document, and agree to abide by the rules and conditions outlined in these documents. I understand that if I do not abide by these rules and conditions, my use of information technology systems may be suspended and my device and / or network access may be confiscated.
- I am aware that the device provided to me remains the property of the school until it is paid in full and that, at any time, it may be inspected by a staff member.

Additionally, I understand that I am also subject to the school's Behaviour Management Policy and its consequences while using ICT systems or resources.
